

Peter Chacon: Conviction Without Silence

The glass elevator at the Holiday Inn on the San Diego (SD) Embarcadero was filled with cheerful Spanish dialects as Peter Chacon won an upset November 1969 California State Assembly election. As he smiled, he carried the struggles of working-class Chicanos, lifting his people into political spaces they had never been allowed to enter.

Born into poverty, Peter Chacon learned from his father, a revolutionary in the Mexican Revolution, that life was a constant battle. His fight for bilingual education became a nonviolent continuation of his father's legacy, challenging the racist, chauvinist thinking that cowed marginalized children into silence. After surviving an attack as a WWII turret gunner, Chacon returned home, becoming first in the family to attend college, while earning degrees in education and school administration.

But through his first teaching position at Sherman Elementary School, his political courage emerged. As the American flag fluttered outside and children pledged allegiance in perfect English, rows of back-of-the-class Spanish-speaking students stuttered, labeled as intellectually disabled and placed into special education classrooms. To Chacon, the problem was clear: American classrooms lacked basic civil rights, as he insisted, "You change the system from within" (Breier).

In the late 1960s, Americans hungered for reform. Federal initiatives such as Lyndon B. Johnson's War on Poverty, the Civil Rights Act of 1964, and The Bilingual Education Act, the first federal legislation to fund bilingual programs in the US, all lacked implementation with underfunding and weak enforcement. Confronting this gap, a coalition of minority activists turned to Peter Chacon as their candidate for California State Assembly.

San Diego, 79th's critical city, was deeply conservative and had never elected a Latino official. Chacon's district itself was only 8% Latino, giving no guarantee that people he aimed to serve could carry him to victory (Chacon). He ran at immense personal risk, selling his own home and cashing in his retirement. Without phone banks, Chacon, alongside his family and

hundreds of volunteers, “walked the district every day for months” (Vasquez). Latino civil rights advocate, Luiz Natividad, remembered how “for the first time in state political elections, [we] went door-to-door on huaraches... selling tortas to pay for his campaign” (Gómez). African American organizers also mobilized under a longstanding coalition agreement: when one marginalized community ran, the other would show up.

Chacon quelled raucous crowds with a steady gaze and a simple “Shall we begin?” (Breier). Running against an entrenched party machine led by Republican incumbent Tom Hom, Chacon won against all odds with 55% of the vote. George Smith, a SD civil rights leader, recalled “The whole district was going to be behind Pete Chacon: Black, Brown, and White” (Gómez). For the Mexican Latinos in SD and beyond, his victory shattered political invisibility. Across California, marginalized communities saw Chacon as a model for coalition power. Chacon held California's 79th District for the next twenty years.

Once in office, Chacon helped found the California Latino Legislative Caucus, now among the most influential organizations in the state legislature, challenging the expectation that Latino legislatures remained symbolic. Amidst this climate of heightened visibility and resistance, Chacon undertook what would be the most consequential and controversial act of his political life. In 1973, he authored Assembly Bill 2284, California’s first state funding for English Language Learners, equipping districts with the resources to hire thousands of bilingual teachers and develop new programs. Yet, Chacon realized the funding itself was useless without mandates.

In *Lau vs. Nichols* (1974), Chinese-American students successfully argued that identical instruction without language support violated their civil rights. While the decision significantly expanded educational rights for English learners, it offered no specific instructions on implementing language access in practice. In response, Chacon advanced the landmark Chacon-Moscone Bilingual-Bicultural Education Act in 1976, mandating equal educational opportunity to students regardless of English proficiency. The law required every California district to identify English learners and provide instruction in their primary language, impacting 230,000 limited-English speakers (Chacon). Today, Chacon’s rejection of the “one-size fits all”

language model echoes across SD classrooms in 58 different languages, from Arabic to Cambodian (DeWyze). Language would no longer be weaponized to label students as un-American.

Opposition roared statewide, with critics accusing Chacon of undermining assimilation. Even his supporters warned that his agenda would alienate voters and end his political career. Chacon refused to retreat, confronting what John F. Kennedy, in *Profiles in Courage*, identified as the gravest political test: “defying the angry power of the very constituents who control his future” (Kennedy 222). Unyielding in the face of resistance, Chacon doubled down with Assembly Bill 507 in 1980, strengthening enforcement and expanding bilingual education across California.

Still, teacher shortages allowed underprepared teachers to be “grandfathered into” classrooms (Billiter). By 1990, Chacon faced one of the most difficult reelection battles of his career as white, English-speaking lawmakers built political armies, branding him as “communist” (Gómez). Journals ranked him next-to last in overall effectiveness in the Assembly, his “help of the poor and minorities” unacknowledged (Horstman). It escalated to a point where Chacon backed out of a planned Democratic primary debate after his opponent, Celia Ballesteros, ran a “campaign of distortion” sending *ad hominem* attack flyers to 25,000 Democratic households across California (Horstman). Despite hostility, he won reelection in 1990 and retired in 1992 after two decades of work.

The clearest measure of his existential courage emerged in how Chacon lived. After retiring, he taught English to farmworkers, Spanish to senior citizens, and bilingual civic lessons to aspiring Latino American citizens. David Valladolid, his former chief of staff, reflected, “He was way ahead of his time...He never saw people by the color of their skin...it was just, *“What can I do to help you?”*” (Breier).

J.F. Kennedy reminds us that “a nation reveals itself not only by the men it produces, but by the men it honors, the men it remembers” (“John F. Kennedy Quotations”). Chacon’s courage

did not shout. It taught, it legislated, and it changed millions of lives without ever accepting the safety of silence.
